NOTICE TO ALL DOGSNT MEMBERS & AFFILIATES UPDATE: 7th MAY 2020 - RE COVID-19 SITUATION

At a Meeting of the DogsNT Council on the 6th May 2020, the following motion was passed concerning theongoing COVID-19 Virus situation:

That DogsNT (North Australian Canine Association Inc), lift the current restrictions imposed due to COVID-19 in accordance with the following strategic plan as outlined in steps 1-5 below and under the current NT Government COVID-19 recommendations and regulations:

- 1. That all training sessions can recommence from **15th May 2020** with a MAXIMUM of two (2) hours per session, in accordance with **STAGE 2** of the NT Government COVID-19 'Roadmap' guidelines.
- 2. That all sanctioned and approved events can be held from the **5th June 2020** as per **STAGE 3** of the NT Government COVID-19 'Roadmap' guidelines with NO time restrictions.
- 3. That the DogsNT Office be opened for business from the **15th May 2020** and that the restriction of only one (1) customer be physically permitted in the Office at one time.
- 4. **i.** That the current DogsNT Rule 3.4.4 relating to the lodgement of pre-event paperwork no less than 'four (4) months prior' be lifted (no longer apply), from the 7th May 2020 until the 31st December 2020. **ii.** All official DogsNT pre-event paperwork is now required no less than four (4) calendar weeks before the proposed event.
- 5. That the above strategies are to be circulated to all
- i. DogsNT Affiliates (via email), and
- **ii.** The Members (via the DogsNT website and social media) with the following additional points included in the correspondence and Notice:
- All Members attending and Affiliates holding sanctioned or approved DogsNT events MUST comply with the NT Government advice and regulations regarding COVID-19.
- Under DogsNT Rule 3.5.2 (c): Persons or dogs participating at any DogsNT sanctioned or approved event do so at their own risk.
- Affiliates holding any sanctioned or approved events will be responsible for cleaning and sanitising the amenities block, Training Room and all other hygiene matters in accordance with the NT Government COVID-19 guidelines.
- If anyone feels unwell do not attend a sanctioned or approved DogsNT event.

RULE CHANGES Section 3 – Exhibitions

1. (**Please note:** due to the COVID-19 situation - the current DogsNT **Rule 3.4.4** relating to the lodgement of pre-event paperwork no less than 'four (4) months prior' be lifted (no longer apply), from the 7th May 2020 until the 31st December 2020. All official DogsNT pre-event paperwork is now required no less than four (4) calendar weeks before the proposed event).

<u>New Rule</u> – **3.4.4** At least four (4) months before the proposed date of ANY Exhibition, the Affiliate shall submit (**NOTE**: Conformation Ring Steward Contracts exempt: see (e) below) (**04/20**): (e) A signed Conformation Ring Stewards contract is to be submitted at least one (1) calendar month before the date of an Exhibition or in such a manner as may from time to time be prescribed by Council for each Exhibition (**04/20**)

(Previous Rule: 3.4.4 - At least four (4) months prior to the proposed date of any Exhibition, the Affiliate shall submit: (e) A signed ring steward contract in such a manner as may from time to time be prescribed by Council for each exhibition).

1. <u>New Rule</u> - **3.5.2 (c)** Persons or dogs participating at any DogsNT sanctioned or approved event do so at their own risk. **(06/05/20)**

(Previous Rule: 3.5.2 - (c) Exhibitors and dogs participating at an Exhibition do so at their own risk.)

FCI JUDGE SUSPENSIONS

The Kennel Association of the Republic of Macedonia (KARM) informs the FCI members and contract partners that **Mr Metodija Zafirovski** has been suspended as FCI international show judge from 01/01/2020 until 31/12/2020.

The Kennel Club of Lebanon (KCL) informs the FCI members and contract partners that **Mr Fadi ITANI** has been suspended as KCL breeder, from **20/02/2020** until **20/02/2024**. In addition, his FCI kennel name "**MOUNTAIN RIVER**" has been cancelled from the international FCI kennel name register.

The WORLD DOG SHOW is postponed to December 2020

From 17 to 20 December 2020, in Feria de Madrid. The decision, approved by the RSCE and the FCI, was taken based on health instructions.

Madrid, 22nd April 2020 - Following an agreement between IFEMA and the Real Sociedad Canina de España, (RSCE) later approved by the Fédération Cynologique Internationale (FCI) decided to postpone the FCI World Dog Show 2020, initially scheduled to take place from 23rd till 26th April 2020 (initially



postponed to 9-12th July, 2020) to 17th-20th December 2020 (Thursday to Sunday). The FCI World Dog Show will take place in the Feria of Madrid.

The decision was taken based on the instructions from the health authorities, taking into consideration the development of the Covid-19 in Spain and in the rest of the world and with the aim of guaranteeing the participation of foreign people in a worldwide event with specific characteristics .

IFEMA, the RSCE and the FCI confirmed their agreement to celebrate the FCI World Dog Show in Madrid, giving a clear response to the high expectations of breeders and exhibitors around the world, as well as the approximately 80 commercial partners that already confirmed their presence.

This decision was positively received by the main sponsor of the event ARION, as well as by the sponsors ARTERO and BAYER, the collaborator ROYAL CANIN and the insurance company MAPFRE, who all renewed their support.

IFEMA will provide its best resources to ensure a successful celebration of this great international event. In practice, pavilions 4, 6, 8, 9 and 10, with more than 86,000 m², will be made available, in order to make enough room for the 84 rings and the Ring of Honor of the WORLD DOG SHOW 2020, as well as the rest of the other exhibitions and the commercial area. Of course, all the relevant security measures will be guaranteed and all the pavilions will be properly air-conditioned.

In the coming days, the RSCE will communicate all the changes related to the new dates that could affect the event program, judges, registrations or cancellations.

ANKC HEALTH & WELLBEING COMMITTEE COVID-19 ADVICE TO BREEDERS



Realising that bitches were mated or whelped prior to the introduction of travel and social distancing restrictions, the CHWC hopes that the following advice will help in the process of transferring puppies to their new owners.

In addition the ANKC has received many inquiries in regard to continuation of breeding during this time of Government limitations, this of course is a personal choice but the ANKC recommends that before you mate a bitch, you give serious consideration to difficulties that may be encountered in relocating puppies to their new homes, transporting puppies both inter and intrastate can be a problem as are limited flights between states.

COVID 19 - the basics

COVID 19 is one of a large group of Corona viruses that affect many species. These viruses, like most, are generally species specific and rarely transfer to or affect any other species.

Both dogs and cats have corona viruses, but these are genetically very far removed from COVID 19. There has been no recorded transfer of dog and cat Corona viruses to humans and vice versa.

Socialising during the COVID 19 pandemic

Because of the limited movement and social distancing of people during the COVID 19 lockdown, breeders will have to be more inventive with their puppy socialisation, particularly if there are no children around.

Lots of play activity, try having different outfits, hats, noises, toys; most of which are usually done anyway. Take a few puppies out at a time in a trolley or pram to walk around the park or the block to see different places, people running past etc.

Do more one on one handling, particularly in those breeds that really need the individualisation (GSD, Rottweiler, etc). Stress to new owners that they will need to keep up this socialisation after they leave your care.

Placing a Puppy during COVID 19 – Safety Advice

- 1. Do most of your normal checks, talking to prospective owners by phone, email, Facebook etc, ahead of time. Send photos, videos of the puppies, how they are being kept and raised, shots of the parents etc.
- 2. Check the credentials of the new owners, safe yards and fencing, members of the family, young children etc. Give copies of the relevant health certificates to people you expect to take a puppy. Have your puppy pack ready with dietary advice, spare puppy food, vaccination certificates etc, all ready to go before people arrive to see the puppy (or puppies).

- 3. Explain to prospective owners ahead of time what to expect. Ask whether anyone has had contact with anyone with COVID 19 or whether they have a cold or flu. Ask that older and/or compromised people and young children do not come to view the puppies. Only allow 1-2 people to come at any one time. Have everyone use a hand sanitizer or soap and water before handling the puppies.
- 4. Put the puppies to be viewed in a playpen, preferably outside, where the puppies can be placed into before the people arrive. Limit the number of puppies brought out. Prospective owners can then handle the puppies without direct contact with you. Any puppies not going can be wiped over with disinfectant (or washed) after the other puppy has gone.
- 5. Have all the paperwork ready, if anything needs signing, use a pen that they can then keep or you wipe it down with disinfectant/hand sanitizer. Keep the time spent with prospective owners to a minimum. Wash your hands and all open surfaces around the puppy area after the people leave.
- 6. With the restrictions on travel and only for essential business, it becomes quite difficult to sell puppies and comply with the necessary requirements. All the advice that we can give is how to limit your exposure to the virus when people come to view puppies.

[Note: It has been brought to our attention that in some jurisdictions people visiting your home, to pick up a puppy may be considered to be non-essential and therefore a finable offence, please check you State or Territory COVID 19 Regulations before arranging for puppies to be viewed or picked up.]
