DOGS NT RULE AMENDMENTS / ADDITIONS

Sec 3 – EXHIBITIONS

New Rule: 3.4.4

NOTE: Due to the COVID-19 situation - the current DogsNT **Rule 3.4.4** relating to the lodgement of pre-exhibition paperwork no less than four (4) months prior be lifted (no longer apply), from the 7th May 2020 until the **31st August 2021**.

ALL official DogsNT pre-exhibition paperwork is now required no less than four (4) calendar weeks before the proposed event. (28/10/2020)

Previous Rule: 3.4.4

NOTE: Due to the COVID-19 situation - the current DogsNT **Rule 3.4.4** relating to the lodgement of pre-exhibition paperwork no less than four (4) months prior be lifted (no longer apply), from the **7th May 2020 until the 31st December 2020**.

ALL official DogsNT pre-exhibition paperwork is now required no less than four (4) calendar weeks before the proposed event.(07/05/2020)

New Rule: 3.4.10

All Affiliates must advertise approved Exhibitions in the official publication of The NACA (DogsNT), in a manner approved by The Council and its Sub-Committees. All Exhibitions must be advertised as a Schedule in the Schedules section of the Territory Dog World (The NACA official publication). Only Exhibitions with consecutive dates can be included on any one (1) Schedule. **(28/10/2020)**

Previous Rule: 3.4.10

All Affiliates must advertise approved Exhibitions in the official publication of The NACA (DogsNT), in a manner approved by The Council and its Sub-Committees (02/20)

FCI JUDGE SUSPENSIONS

The **Cyprus Kennel Club (CKC)** informs the FCI members and contract partners that it does not recognise any more the **Cyprus Kurzhaar Club** and the **Cyprus Epagneul Breton Club**.

Consequently:

- a. Any event (shows or trials) or results of events organised by the above two clubs will no longer be approved.
- b. The clubs are no longer allowed to represent Cyprus at any national or international organizations/clubs/competitions of the breeds represented.
- c. The FCI members and contract partners are invited to inform CKC about any communication they get from those clubs.

Ukrainian Kennel Union (UKU) informs the FCI members and contract partners that **Mrs Alla DERDIUK** has been suspended as UKU member and breeder (FCI kennel name: **CHERRY MERRY TAILS** since 15/09/2020 until further notice.

Consequently, she is not allowed to perform any breeding activities until further notice.

The international FCI Kennel Name Register has been updated by the FCI Head office accordingly.

The **Cyprus Kennel Club (CKC)** informs the FCI members and contract partners that **Mr George GEORGIU** has been definitively excluded as CKC member and international judge, **since 9/12/2019**. Consequently, he is no longer allowed to officiate at any FCI international shows or trials.

WORLD DOG SHOW POSTPONED UNTIL 2022

Madrid, October 13th, 2020: The Fédération Cynologique Internationale (FCI), IFEMA & the Real Sociedad Canina de España (RSCE), organisers of the FCI World Dog Show 2020, which was going to be held in Feria de Madrid from December 17th - December 20th, further to several postponements of its original dates in April & then July, have decided to postpone this worldwide canine event to 2022, due to the situation created by Covid-19.

IFEMA had taken a whole set of measures & protocols in order to ensure the participation in the Dog Show under fully guaranteed safety conditions. However, the evolution of the pandemic & the various sanitary conditions at international level make it advisable to postpone the event, in order to answer the high expectations & the anticipation a worldwide event of such importance had generated for companies, exhibitors & enthusiasts from all over the world.

The FCI & the RSCE would like to express their gratitude to the generosity, the solidarity & the cooperation of Brazil - through their national canine organisation, CBCK - which being conscious of the seriousness & the peculiarity of the current situation, as well as of RSCE's efforts to guarantee the celebration of the FCI World Dog Show, has agreed to hold two World Dog Shows in 2022: the FCI World Dog Show in Spain & the FCI World Dog Show in Brazil (where the coveted & exclusive 2020 and 2022 "FCI World Winner" titles will be respectively awarded).

This way, 2022 will be a paradigmatic year, a model of the values & ideals of friendship, solidarity, cooperation & respect on which the FCI is based.

The RSCE & the CBCK are grateful for the predisposition & the support of the FCI General Committee, especially of the FCI's President, to a good outcome of the proper negotiations.

In the next few days, the RSCE will inform further about the final dates & about all the changes related to this new situation.

OCTOBER 2020 AGM & BOARD MEETING SUMMARY

At the recent Annual General Meeting of the Australian National Kennel Council Limited held via Zoom video conferencing:

1. Election of ANKC Ltd Executive

- Mr Brian Parker was elected as Vice President for a one-year term from 17 October 2020; and
- Mr David Sales was re-elected unopposed as Treasurer for a one-year term from 17 October 2020.
- Ms Pamela Campbell was re-elected as a member of the Executive Committee for a one-year term from 17 October 2020.

At the October 2020 ANKC Ltd Board meeting, Directors resolved/considered the following:

1. Turkish Shepherd Dog Survey

It was resolved that the status quo remain where there will be two breeds with the Anatolian Shepherd Dog using the current Anatolian Shepherd Dog breed standard and the Kangal Shepherd Dog using the FCI Kangal Shepherd Dog breed standard and owners may transfer the affected dogs from one breed to the other up until the 30 June 2021.

2. CACIB Shows: 2022-2023

3. * Regulations Part 3A to 3N: New Clause to be added

It was resolved that the following clause be inserted into all ANKC Ltd Regulations Part 3A to Part 3N:
A member wishing to enter any Judges' Training Scheme must apply to the Member Body in their state of residence.

4. * Regulations Part 5 – Conformation Shows: Clause 1.1.7 Amendment

It was resolved that Regulations Part 5 – Conformation Shows: Clause 1.1.7 be amended as follows:
 1.1.7 *Proprietary Interest – having some legal or equitable interest in an animal on an on-going basis. For the purposes of these Regulations the definition does not include boarding a dog at a Judge's boarding kennel.*

5. * Regulations Part 5 – Conformation Shows: New Clause 8.1.4 Amendment

It was resolved that Regulations Part 5 – Conformation Shows, Section 8, 8.1 Exhibit be amended by the inclusion of an additional Clause 8.1.4 to read as follows:

8.1.4 *A dog cannot be entered in the name of a deceased person once the administration of that person's estate has been finalised.*

6. * Regulations Part 5 – Conformation Shows: Clause 3.2.5 Amendment

It was resolved that Regulations Part 5 – Conformation Shows: Clause 3.2.5 be amended as follows:
*"I undertake to abide by the Rules and Regulations of the ANKC Ltd and judge to its approved Breed Standards/Regulations/Rules and any member body regulations applicable to this assignment. I declare all information on this form is correct and if circumstances make the information inaccurate, I undertake to inform the ANKC Ltd forthwith.
 I also declare I am physically fit and capable of judging in the normally accepted manner. I acknowledge this is a continuing obligation and I undertake to notify the contracting affiliate should my health status impact upon my ability to judge in the normally accepted manner."*

It was resolved for the amended declaration to be included in the Judges' contract and the Non-resident Judges' application form.
