2. **NOVICE AND COMBINED CCD/NOVICE JUDGING LICENCE:**
The applicant has personally trained and trialed a dog the ANKC minimum standard.
3. **OPEN JUDGING LICENCE:**
The applicant must have an ANKC Ltd Novice Judging Licence.
Judged at least three (3) Novice Obedience classes at sanctioned obedience trials.
4. **UTILITY JUDGING LICENCE:**
The applicant must have an ANKC Ltd Open Judging Licence.
Judged at least three (3) Open Obedience classes at sanctioned obedience trials.

5. UTILITY DOG EXCELLENT JUDGING LICENCE:

The applicant must have an ANKC Ltd Utility Judging Licence.
Judged at least three Utility Obedience classes at sanctioned obedience trials.
