FCI SUSPENSIONS AND EXCLUSIONS

FCI EXCLUSION

Ukrainian Kennel Union (UKU) informs the FCI members and contract partners that Mrs Pochekuyeva-Dobarska Larysa (UA117) has been definitively excluded as international show judge, since 17/12/2020. The FCI Judges Directory has also been updated by UKU accordingly.

FCI SUSPENSION

Ukrainian Kennel Union (UKU) informs the FCI members and contract partners that **Mr GERGEL Yurii (UA48)** has been suspended as international show judge, for a period of 1 year, from **17/12/2020** until **16/12/2021**. The FCI Judges Directory has also been updated by UKU accordingly.

FCI NON RECOGNISED ORGANIZATION IN ROMANIA

The Asociatia Chinologica Romana (A.Ch.R.) informs the FCI members and contract partners that the Uniunea Chinologica Royal (UCHR) neither is a member of the A.Ch.R. nor is recognized by the A.Ch.R.. According to the Article 7.4. of the FCI Statutes, we remind that "membership is open to only one category per country (Full Member, Associate Member and Contract Partner), not being possible to recognize, simultaneously, several National Canine Organisations." The A.Ch.R. is the only FCI member in Romania. Consequently, the FCI does not recognize the Uniunea Chinologica Royal neither its events nor its kennel names, pedigrees or judges.

CIRCULAR 28/2020: COVID-19 AND FCI INTERNATIONAL EVENTS

With reference to our circular 28/2020 dated 05/06/2020 and since the Covid-19 pandemic keeps affecting our countries more or less severely depending on the nations, the FCI General Committee decided to extend the deadline for the measures listed **BELOW UNTIL FURTHER NOTICE**, in order to promote again FCI international events and help their organisers, in full compliance with the national legislations:

- 1. Since judges may feel unsure about or be prevented from travelling abroad, FCI International CACIB shows and FCI international working events can be held with judges from the judges list of the organising member or contract partner only.
- 2. Since national legislations may prove to be very strict in the future regarding the organisation of mass events, it is allowed to conduct FCI International CACIB shows without any competition being held in the main ring (BIG, BIS, ...). However, breed judging (where CACIB is awarded) MUST be organised.
- 3. All organisers of FCI international CACIB shows and FCI international working events are required to comply as a minimum with their national legislation regarding hygiene and safety measures (social distance, masks, ...) when organising an FCI international competition. We also remind our members and contract partners about our communication dated March 2nd 2020, about the same matter.

RECLASSIFICATION OF 'TORNJAK'



The National Breed Standards Coordination Group has considered a request for the reclassification of the Tornjak from Group 5 to Group 6.

The Group has noted and agreed that as the Tornjak is an FCI breed which has been allocated by its registering body and country of origin into FCI Group 2.2 which covers all the mountain dwelling Livestock Guardian breeds such as the Pyrenean Mountain Dog, Caucasian Shepherd Dog, Central Asian Shepherd Dog and the Kangal which are normally placed in our Group 6, they have agreed to the request.

As a result, this breed will now be moved from Group 5 to Group 6. We are arranging for our website and Group listing to be updated accordingly.

FCI BREED TO BE ADDED TO THE NATIONAL BUSINESS SYSTEM – DACHSHUND KANINCHEN

Please note an application has been received for re-registration of the following FCI recognized breed:

- Dachshund Kaninchen (Smooth)
- Dachshund Kaninchen (Long)
- Dachshund Kaninchen (Wire)

This breed has been added to the business system and we are currently arranging for our website to be updated with the relevant breed standard.

In addition, the ANKC Group listing will be updated with this breed being allocated to **Group 4 (Hounds)** as confirmed by the National Breed Standards Coordination Group. The Group has also confirmed the following amendment to *Regulations Part 6 – The Register & Registration Clause 9.13:*

9.13

Dachshund (Long Haired); Dachshund (Miniature Long Haired); Dachshund (Kaninchen Long Haired); Dachshund (Smooth Haired); Dachshund (Miniature Smooth Haired), Dachshund (Kaninchen Smooth Haired);

Dachshund (Wire Haired), Dachshund (Miniature Wire Haired); Dachshund (Kaninchen Wire Haired):

- All Judged separately with each variety receiving separate Challenge Certificates.
- Intervariety breeding is NOT approved.
- Reclassification of size type NOT permitted.
- Reclassification on coat type between size same types is permitted.

OCTOBER 2020 BOARD MEETING MINUTES AMENDMENTS



In accordance with the confirmed October 2020 Board meeting minutes **Regulations Part 5** has been amended as follows:

Items 5.8 - by the inclusion of an additional Clause, numbered 8.1.4, to read:

• **8.1.4** A dog cannot be entered in the name of a deceased person once the administration of that person's estate has been finalised.

[NOTE: Dogs NSW drafted their original submission for the February 2020 Special Board meeting prior to the final submission from the Regulations Part 5 Review Working Party being endorsed which was a complete review of the regulations. As a result, the new clause has been added as Clause 11.1.7 and the current 11.1.7 and 11.1.8 has been re-numbered accordingly.]

• **Item 7.5.7 - Clause 1.1.7** be amended to read:

SECTION 1 – Definitions and Classes

1.1 Definitions

1.1.7 Proprietary Interest – having some legal or equitable interest in an animal on an on-going basis. For the purposes of these Regulations the definition does not include boarding a dog at a Judge's boarding kennel.

• Item 7.5.8 – Clause 3.2.5 be amended to read:

"I undertake to abide by the Rules and Regulations of the ANKC Ltd and judge to its approved Breed Standards/ Regulations/Rules and any member body regulations applicable to this assignment. I declare all information on this form is correct and if circumstances make the information inaccurate, I undertake to inform the ANKC Ltd forthwith.

I also declare I am physically fit and capable of judging in the normally accepted manner. I acknowledge this is a continuing obligation and I undertake to notify the contracting affiliate should my health status impact upon my ability to judge in the normally accepted manner."

The updated regulations are now available from our website.

ERROR: REGULATIONS PART 5 – CONFORMATON SHOW: Clause 11.3.1

It has been brought to the attention of the ANKC Executive Committee that an error has occurred in Regulations Part 5 – Conformation Show, **Clause 11.3.1**. After consideration, the Committee has agreed this is a grammatical error and should be rectified. As a result, the clause will be amended as follows:

Currently reads:

11.1.3 No cutting, piercing, breaking by force or any kind of operation or act of a like kind which alters the natural formation of the dog is not permitted except as provided for in the Breed Standard.

Amend to read:

11.1.3 Cutting, piercing, breaking by force or any kind of operation or act of a like kind which alters the natural formation of the dog, is not permitted except as provided for in the Breed Standard
