SANDRA HELEN LEW-FATT

It is with the heaviest of hearts and great sadness that we advise of the passing on Friday 9th of April 2021 of Mrs Sandra Lew-Fatt.

A tireless volunteer, Sandra was awarded a DogsNT Life Membership for the huge contribution that she made to the Northern Territory (NT) dog world, to DogsNT (NACA) and its Affiliates. Always willing to help, guide & mentor, Sandra was known & respected by so many throughout Australia.

Sandra was a very influential member of the dog world in the NT and here are just a few of the milestones and memories she created:

- She was the first person to 'fly' into Darwin with her dogs;
- Held the positions of DogsNT (NACA) Vice-President, Councillor and Committee Member on many NT dog Clubs;
- Was the first to Title the following breeds in the NT: Lowchen and Shiba Inu (bred by the late GAA Lane);
- Registered the first NT litters of: Belgian Shepherd (Groenendael), Dobermann, Japanese Spitz and Shiba Inu;
- First became involved with Irish Setters in 1969, Whippets in 1975 and Belgian Shepherds in 1982;
- Commenced Darwin Obedience Dog Club Inc - along with Mary Bickerton and Bob and Di Oaten – along with many other wonderful Members and volunteers;
- She started competing in Obedience way back in 1962 with her German Shepherd Dogs and Corgis, and 'Top-Scored' in the very first ever Obedience Trial held in Darwin with her German Shepherd Dog – proudly winning the 'Martin Finger Award';
- Sandra was so passionate about her German Shepherd Dogs that she actively campaigned and was influential in overturning the Legislation that, until that point, meant that German Shepherd Dogs had to be neutered in the NT. Thanks to her, and many others, this breed was eventually permitted to remain 'entire' in the NT;
- She introduced Dog Show Bags at the Royal Darwin Show and helped organise the very first Pet Expo (along with Joy Nye - who also got the RSPCA involved);
- Sandra started Conformation Showing way back in 1960 and titled more than 75x dogs (many being home-bred), 3x Grand Champions and successfully showed in the eastern States. Some of her many wins included winning Challenge with her Italian Greyhound at Melbourne Royal and Class of Breed – also at Melbourne Royal – with her lovely Irish Terrier;
- Of course, her family was also heavily involved with the dog world and her son Keenan won the State Junior Handler Finals an amazing 3x times. He was the first male to represent the NT interstate and Sandra devoted much of her time mentoring many other State Finalists;
- Her famous prefix 'Aasky' was even made up using her family's names – AJ, Anita, Sandra, Keenan, and Yvette – not forgetting her grandson Tyson.

To sum up her devotion and love for canines – when asked *"what breed of dog is your heart breed"*? Sandra ALWAYS smiled and gave the same wonderful answer *"Dogs"*.

Sandra was farewelled by her family and friends at St Mary's Star of the Sea Cathedral, Darwin on Thursday the 22nd of April 2021, and her knowledge, experience, enthusiasm, and mischievous sense of humour will be missed by so many. On behalf of the DogsNT Council and Members, we extend our condolences and deepest sympathies to Sandra's loved ones.

LITTER REGISTRATION NOTICES – TERRITORY DOG WORLD

Due to a recent Australian National Kennel Council Ltd directive, DogsNT, along with all the other Member Bodies, is no longer permitted to publish Litter Registrations in the Territory Dog World.

DOGSNT RULE AMENDMENTS AND ADDITIONS

Section 5 - Judges

Amended Rule: 5.8 - Judges Code Of Practice And Conduct -5.8.17:

A Judge shall avoid duplicating assignments in the same State within six (6) months of each other for ALL Exhibitions and three (3) months for Open Exhibitions except with the written consent of each Affiliate or Body concerned. **(04/21)**

(Previous Rule – 5.8.17: A Judge shall avoid duplicating assignments in the same State within six (6) months of each other for Conformation Exhibitions and three (3) months for Open Exhibitions except with the written consent of each Affiliate or Body concerned).

Section 3 - Exhibitions

New Rule Added: 3.4 – Permission: Prior To Event - 3.4.4 - f):

An Affiliate may contract multiple Ring Stewards to a maximum of three (3) Ring Stewards for any single Exhibition. Where multiple Ring Stewards are contracted for an Exhibition, each Ring Stewards contract MUST state the Group/s and/or Specials (as applicable) the Ring Steward is contracted to steward for. **(27/04/21)**

New Rule Added: 3.6 – Entries: Eligibility To Enter An Exhibition - 3.6.14:

A contracted Ring Steward may exhibit, and handle exhibits owned by them at the same Conformation Exhibition PROVIDED they do NOT handle any dogs in the Group/s and/or Specials for which they are contracted to Ring Steward. **(27/04/21)**

TICK-BORNE DOG DISEASE - EHRLICHIOSIS IN THE NORTHERN TERRITORY

Ehrlichia canis is a nationally notifiable disease.

We need your help to spread the word that the tick-borne dog disease ehrlichiosis has been detected in the Territory. Biosecurity is a shared responsibility, and we need your support to build community awareness of everyone's role to stop transmission of the bacteria *Ehrlichia canis*.

Ehrlichiosis is transmitted to dogs by the brown dog tick, which is widespread in northern Australia. Prevention is the best protection for dogs as vaccinations are not presently available. All dog owners are strongly encouraged to have their dogs on a tick control program, regularly check their dogs for ticks, and be on the lookout for signs of the disease.

For up-to-date official information, prepared by the Department of Primary Industry, the Northern Territory and Australian Governments, DogsNT encourages you to please follow the link below for fact sheets and information, then share these materials, as relevant, as increased awareness of this disease throughout the community will help to protect our four-legged friends from ehrlichiosis.

COVID-19 AND FCI INTERNATIONAL EVENTS



With reference to our circular 28/2020 dated 05/06/2020 and since the Covid-19 pandemic keeps affecting our countries more or less severely depending on the nations, the FCI General Committee decided **to extend the deadline** for the measures listed BELOW **UNTIL FURTHER NOTICE**, in order to promote again FCI international events and help their organizers, in full compliance with the national legislations:

1. Since judges may feel unsure about or be prevented from travelling abroad, FCI International CACIB shows and FCI international working events can be held with judges from the judges list of the organizing member or contract partner only.
2. Since national legislations may prove to be very strict in the future regarding the organization of mass events, it is allowed to conduct FCI International CACIB shows without any competition being held in the main ring (BIG, BIS, ...). However, breed judging (where CACIB is awarded) **MUST** be organized.
3. All organizers of FCI international CACIB shows and FCI international working events are required to comply - as a minimum - with their national legislation regarding hygiene and safety measures (social distance, masks, ...) when organizing an FCI international competition.

We also remind our members and contract partners about our communication dated March 2, 2020.

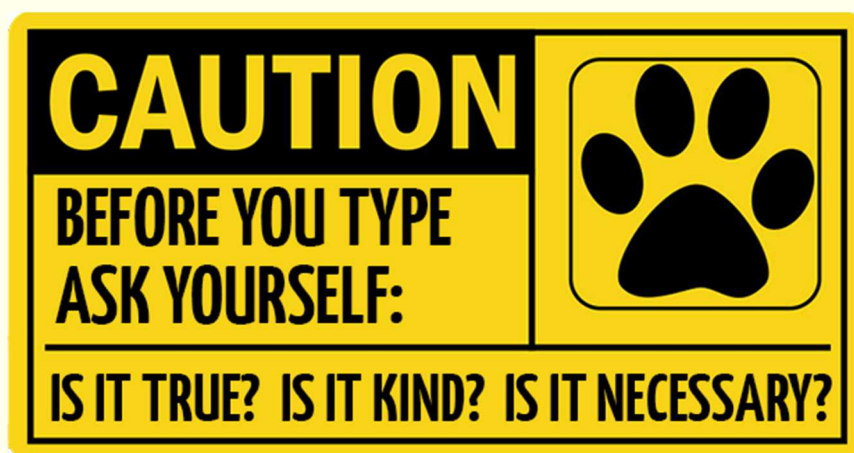

CHANGE TO BREED STANDARD - WHIPPET

Please note we are arranging the following change to the Colour section in the standard of the Whippet on our website to ensure consistency with the Kennel Club (UK) standard.

Currently reads: Any colour or mixture of colours.

Amend to read: Any colour or mixture of colours, except merle.

ANKC SPECIAL BOARD MEETING SUMMARY – FEBRUARY 2021

At the February 2021 ANKC Ltd Special Board meeting, Directors resolved/considered the following:

1. * ANKC LTD REGULATIONS PART 6 – THE REGISTER & REGISTRATION

It was RESOLVED that **Regulations Part 6 – The Register & Registration, Section 3-Imported Dogs, Clause 3.2** be amended to read:

3.2 All pedigree dogs that are imported into Australia except those imported from New Zealand (including dogs whelped in Australia and previously exported from Australia) to be re-registered with ANKC Ltd must provide, at the time of registering the dog the following:

- a. Proof of identification, i.e. microchip or tattoo
- b. Proof of Importation, such as a "health permit", "export permit" or "import permit"
- c. An original Export Pedigree and Ownership Certificate (if two separate documents) indicating the Australian member's name and current residential address showing all registration numbers, titles granted and colours by the overseas body. The Export pedigree must be at least first and second generations complete and the 3rd generation a maximum of 4 names missing.
- d. Proof of Shipment from the country of origin to Australia such as transportation documents "Airway Bill" OR an Authorised Agency under the Bio Security Act 2016, Bio Security Release form (b and c above are not required if you have the DAWR release)
- e. Delete

Note: This amendment to the regulations will be effective 1 July 2021.

ANKC SPECIAL BOARD MEETING SUMMARY – FEBRUARY 2021

2. * ANKC LTD REGULATIONS PART 6 – THE REGISTER & REGISTRATION

It was RESOLVED that **Regulations Part 6 – The Register & Registration, Section 6** be amended to read:

6.3.4.8 Effective from 1st January 2017 French Bulldog: Solid Black, Black & White, Black and Tan, Mouse, Grey/Blue, Liver/Chocolate, or French Bulldogs showing marked variation from those colours listed in the Breed Standard and all patterns of these colours (including those registered in other countries) can only be registered on the Limited Register, flagged “not to be upgraded”. **(Added 10/16, 9.9) (Amended 02/21, 5.2)**

AND

the inclusion of an additional Clause, numbered **6.3.4.9**, to read as follows:-

6.3.4.9 Effective from 1 July 2021

No ‘Merle’ French Bulldogs can be registered on any ANKC Ltd register and a ‘Merle’ French Bulldog imported into Australia cannot be registered on any register. No ‘Long Coat or Hairless’ French Bulldogs can be registered on any ANKC Ltd register. **(Added 02/21, 5.2)**

NOTE: This amendment to the regulations will be effective 1 July 2021.

3. * ANKC LTD REGULATIONS PART 8 – MEMBER BODIES & MEMBERSHIP

It was RESOLVED that **Regulations Part 8 - Member Bodies & Membership, Section 2:** Membership be amended by the inclusion of new Clauses, numbered **2.1, 2.2, 2.3 & 2.4**, which read:-

2.1 A member of an ANKC Ltd Member Body must, as a minimum, be a member of the Member Body for the jurisdiction in which they reside. This membership shall be regarded as the person’s Primary Membership. A member of a Member Body shall have a maximum of 1 (one) Primary Membership. This will not prevent persons from joining the Member Bodies of other jurisdictions, either individually or in partnership.

2.2 Each Member Body shall determine what qualification/s it recognises as proof of residency.

2.3 A person shall only be permitted to transact all member services, i.e.: register and maintain a prefix, register a litter or a dog, apply for a title or participate in a Judges Training Program, or undertake an activity similar to aforementioned, in the jurisdiction in which they hold their Primary Membership as defined in **2.1**, above.

2.4 In relation to a partnership, a least one of the partners must hold their Primary Membership in the jurisdiction where the partners are attempting to undertake an activity, as described in **2.3**, above.

AND

THAT the current Clauses, numbered 2.1, 2.2 & 2.3, be re-numbered accordingly.

NOTE: This amendment to the regulations will be effective 1 July 2021.

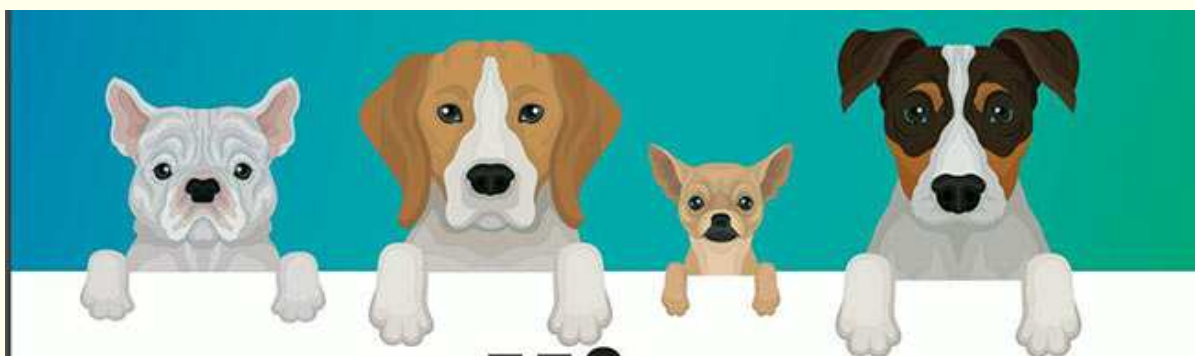
