SECTION 3 - EXHIBITIONS

PREVIOUS RULE:

3.38 - EXHIBITION PAPERWORK

3.38.1: Properly compiled chart(s) must be provided for each Judge. Chart/s must be signed by the Judge. The Exhibition Manager shall retain for at least three (3) months from the last day of the Exhibition; any documentation not submitted to the NACA.

AMENDED RULE:

3.38 - EXHIBITION PAPERWORK

3.38.1: Properly compiled chart(s) must be provided for each exhibition (hard copy or electronic). Chart/s must be signed by the Judge (hand-signed or electronic signature). The Exhibition Manager shall retain for at least three (3) months from the last day of the Exhibition; any documentation not submitted to the NACA. **(19/05/2022)**

TRAVELLING IN THE NORTHERN TERRITORY AND EHRLICHIOSIS

Remember, the tick-borne dog disease Ehrlichiosis has been confirmed in Northern Territory.

We need your help to spread the word that the tick-borne dog disease Ehrlichiosis has been detected in the Territory. Biosecurity is a shared responsibility, and we need your support to build community awareness of everyone's role to stop transmission of the bacteria 'Ehrlichia canis'.

Ehrlichiosis is transmitted to dogs by the brown dog tick, which is widespread in northern Australia. Prevention is the best protection for dogs as vaccinations are not presently available. All dog owners are strongly encouraged to have their dogs on a tick control program, regularly check their dogs for ticks, and be on the lookout for signs of the disease.

FCI NOTICES

UKRAINIAN KENNEL UNION: UPDATE

Due to the conflict in Ukraine, many Ukrainian breeders and owners had to leave their country with their dogs, sometimes with new-born puppies and/or pregnant females. The latter will or have whelp(ed) in countries different from Ukraine.

The Ukrainian Kennel Union (UKU), aware of the situation, put forward a proposal to the FCI General Committee, which was accepted on March 16, 2022. The proposal is as follows:



a) In case a bitch has whelped while being in a country (FCI member) different from Ukraine, export pedigrees will be issued by UKU according to the following procedure:

A local veterinarian microchips the puppies in due age, vaccinates them, checks up the testicles, bite, for other possible anomalies like broken tail, etc, and issues the relevant certificate.

The breeder/person taking care of the bitch and puppies sends this certificate online to UKU (https://notline@uku.com.ua) as well as the other relevant documents required by UKU (information about dam and sire, etc).

A UKU cynologist, via a video connection, checks the microchip and the conformation of the puppies and issues the documents for the puppies (puppy cards) in digital copy. FINAL STEP: the electronic puppy cards are sent back by email to the breeder/person taking care of the dog. Later on, the electronic puppy cards will be exchanged for the export pedigrees by the new owners of the dogs.

b) Regarding the issuance of export pedigrees for Ukrainian dogs sold or to be sold, the procedure is as follows:

The new dog owner sends by email to UKU (hotline@uku.com.ua) a copy of the puppy card/of the pedigree under the name of the previous owner/of the electronic puppy card, the information about himself/herself and a bank receipt for the payment for the pedigree.

FINAL STEP: UKU sends by email to the dog owner the digital copy of the UKU Export pedigree. The digital copy can be later replaced by the genuine paper document once Ukrainian postal service starts working again.

Any puppy card/export pedigree obtained according to the above procedure will be accepted by all FCI Members and Contract Partners.

DOGS AUSTRALIA: MURRAY RIVER RETRIEVER.

Dogs Australia confirm the Murray River Retriever has been added to the business system and noted below are the requirements for registration.

Requirements for a Murray River Retriever, currently registered with the Murray River Retriever Association to be transferred to the Dogs Australia main register.

- 1. Must provide original pedigree with the Murray River Retriever Association.
- 2. Must Provide letter from Murray River Retriever Association approving the transfer of the dog to the Dogs Australia main register.
- 3. Owner/s must be a financial member of a Dogs Australia State or Territory Member Body.
- 4. Transfer between registers fee must be paid.
- 5. Dog will keep the registration name and number that it holds with the Murray River Retriever Association.
- 6. On application by the owner/s, a Murray River Retriever, currently on a Dogs Australia Sporting Register will be transferred to the Dogs Australia main register.

Requirements for the Registration of a litter of Murray River Retrievers:

- 1. Dam owner/s must be a financial member/s of a Dogs Australia State or Territory Member Body.
- 2. The Dam owner/s must hold a Dogs Australia prefix.
- 3. Sire and Dam must be registered on the Dogs Australia main register.

DOGS AUSTRALIA: AUSTRALASIAN BOSDOG.

Dogs Australia confirm the Australasian Bosdog has been added to the business system and noted below are the requirements for registration.

Requirements for an Australasian Bosdog currently registered with the Australasian Bosdog Society Inc to be transferred to the Dogs Australia main register.

- 1. Must provide original pedigree with the Australasian Bosdog Society Inc.
- 2. Must Provide letter from the Australasian Bosdog Society Inc approving the transfer of the dog to the Dogs Australia main register
- 3. Owner/s must be a financial member of a Dogs Australia State or Territory Member Body
- 4. Transfer between registers fee must be paid
- 5. Dog will keep the registration name and number that it holds with the Australasian Bosdog Society Inc.

Requirements for the Registration of a litter of Australasian Bosdogs.

- 1. Dam owner/s must be a financial member/s of a Dogs Australia State or Territory Member Body.
- 2. The Dam owner/s must hold a Dogs Australia prefix.
- 3. Sire and Dam must be registered on the Dogs Australia main register.



RETRIEVING & FIELD TRIAL "HALL OF FAME" - 2022 NOMINATIONS

In the first nineteen years of elections, the Australian National Kennel Council Ltd has received nominations for 56 dogs and 41 people to be considered for induction into the Retrieving & Field Trial Hall of Fame. From the nominations received 34 outstanding dogs and 24 exceptional people have been inducted.

The criteria for the two categories for selection are the following:

Outstanding Gundogs (must be permanently retired from further competition and have not competed for the past 12 months, or be deceased)

- Their record as a winning dog i.e., CLUB STAKE DATE JUDGE PLACE and/or
- Their production record.
- The eligibility for a dog should be based on its entire competitive career and previous record as a producer, not merely for a particular win or for a heroic deed within the field and retrieving trial sphere.
- Subject to the receipt of a formal application, dogs that have been awarded the title of Grand Champion and have gained a total number of points equal to, or greater than, twice the total number required for that award, shall automatically be inducted into the Hall of Fame. Such applications must include full particulars and a brief resume of the dog's career.
- Subject to the receipt of a formal application, dogs winning at least two National Championships in the same discipline shall automatically be inducted into the Hall of Fame. Such applications must include full particulars and a brief resume of the dog's career.

Prominent Persons:

Their record of a broad combination of accomplishments as:

- Club official
- Judge
- Owner
- Handler

The distinction of nomination should be accorded to those who have made outstanding contributions to the field or retrieving game. Nominees should be givers to the sport and not takers.

Nominations are now being called for the current year. In addition to applications submitted in relation to Outstanding Gundogs 1 (d) and 1(e), a maximum of two other outstanding gundogs and two prominent persons may be elected each year.

RETRIEVING & FIELD TRIAL "HALL OF FAME" - 2022 NOMINATIONS



Nomination:

• Clubs or Members may nominate DOGS and PEOPLE considered worthy of awards, including full details of accomplishments within the above categories and with verification. In the case of dogs, nominations should include the full name, title, owner and date of birth.

[Please note it is a condition of nomination that the nominator/s provides accurate written material supporting the nomination. In the absence of such accurate supporting material, or should the supporting material later prove to be inaccurate in areas of significance, the Selection Panel for the ANKC Ltd Retrieving & Field Trial Hall of Fame reserves the right to reconsider its decision and if appropriate, delete the name of the Prominent Person or Outstanding Dog from the list of inductees.]

Nominations shall close on the 31 May 2022 at respective Member Body offices for forwarding to ANKC Ltd.

SUMMARY OF THE DOGS AUSTRALIA SPECIAL BOARD MEETING - HELD VIA ZOOM VIDEO CONFERENCING ON 12 FEBRUARY 2022.

At the February 2022 ANKC Ltd Special Board meeting, Directors resolved/considered the following:

1. * ANKC Ltd Regulations Part 5 – Conformation Shows.

It was RESOLVED that Clauses 10.6.2 and 10.6.3 of ANKC Regulations Part 5 - Conformation Shows be amended to read:

10.6.2 Points shall be allotted for exhibits six (6) months of age and over exhibited in a Neuter Class as follows: (Amended 02/22, 5.1 - Effective 01/07/22)

a. Neuter Certificate winner – Dogs and Bitches.

Five (5) points plus one (1) point for each Neutered dog of the breed over the age of six months exhibited at the fixture.

b. Best of Neuter Certificate winner.

Five (5) points plus one (1) point for each neuter dog and bitch of the breed over the age of six months exhibited at the fixture.

c. Best Neuter in Group winner.

Each winner of the recognized seven (7) groups or ten (10) at CACIB shows – five (5) points plus one (1) point for each Neuter dog and bitch over the age of six months and exhibited in the Group at the fixture.

d. Runner up to Best Neuter in Group.

Each Runner Up in the recognized seven (7) groups or ten (10) at CACIB shows – ten (10) points less than the Best Neuter in Group Winner or breed points whichever is higher, with the minimum being six points.

e. Best Neuter in Show winner.

Five (5) points plus one (1) point for each Neuter dog and bitch exhibited in the Show or breed points whichever is higher, with the minimum being six points.

f. Runner up to Best Neuter in Show.

Ten (10) points less than the Best Neuter in Show Winner or breed points whichever is higher, with the minimum being six points.

10.6.3 The points awarded under (a), (b), (c), (d), (e) and (f) above shall not accumulate and shall, in no case, exceed twenty-five (25) points at any one Show.

Note: This amendment to the regulations will be effective 1 July 2022.

2. * ANKC Ltd Regulations Part 6 – The Register & Registration.

It was RESOLVED that **Regulations Part 6 – The Register & Registration** be amended with the inclusion of new Clause 8.16 to read:

8.16 Afghan Hound (Added 02/22 - 6.1).

The Minimum Breeding Age for Afghan bitches is 24 months at the time of mating (unless a veterinary certificate is produced stating that for health reasons the bitch should be mated before 24 months).

The Minimum Breeding Age for Afghan Hound bitches, breeders of litters whelped on or after 1st June 2022, will be required to comply with the requirements as a prerequisite to registration of any litter on the ANKC Ltd Main Register. Litters which do not meet the above requirements will only be able to be placed on the Limited Register and will be flagged not to be upgraded.

and the existing Clauses 8.16, 8.17 and 8.18 will be renumbered.

Note: This amendment to the regulations will be effective 1 July 2022.

3. * ANKC Ltd Regulations Part 13 - Regulations for the Conduct of National Breed Councils.

It was RESOLVED that **Regulations Part 13 – Regulations for the Conduct of National Breed Councils clauses 2.3.1** be amended to read:

2.3.1 The Membership of a National Breed Council must be comprised of at least two (2) Specialised Breed Clubs, each affiliated with a separate Member Body of the ANKC Ltd.

And the removal of Clause 2.3.2.

Note: This amendment to the regulations will be effective 1 July 2022.

4. Tenterfield Terrier – Extension to the Breed under Development

It was RESOLVED that the Tenterfield Terrier Breed under Development be extended for five years from 1 January 2022.

5. Recognition of the Sport of Canine Disc.

It was RESOLVED that the agreement between Dogs Australia and Canine Disc Australia Ltd be endorsed in principle and for it to be referred to the National Legislative Committee for any necessary amendments in liaison with the Canine Disc Australia Ltd.

6. Breeders Terms Contracts.

It was RESOLVED that all Member Bodies review the transfer of dogs in their State and Territory in the context of breeders terms contracts and other guardianship arrangements and provide feedback to the October 2022 Board meeting; and for Dogs Australia to obtain legal advice from a legal specialist in the context of sale of goods/consumer protection legislation for distribution to Member Bodies.
