IMPORTANT NOTES:

- OWNERSHIP OF THE KENNEL PREFIX AND THE DAM MUST BE IDENTICAL AND LINKED TO A FINANCIAL MEMBERSHIP.**
- Breeders **must** be a resident of the Northern Territory and be a member of the North Australian Canine Association.
- A Northern Territory residential address, **NOT** a PO Box, must be linked to the breeders' prefix.
- A dog's name must not exceed thirty (30) characters including the prefix.
- Certain words are not permitted as common names. These words including already registered Prefixes are 'OF', 'CHAMP', 'IMP', and numbers (eg: I, IV etc) hyphens and apostrophes.
- It is mandatory that Dogs NT Membership number must be included in any advertising of puppies - whatever the media.
- An application of registration may be lodged at any time within eighteen (18) calendar months of the date of whelping.
- An application received must accompany the current fees. Fees are available on the DogsNT website.
- The owner/s of the sire or the owner of the frozen semen should complete all details of the Service Certificate and this must be countersigned by the owner/s of the bitch.
- Overseas registered sires or dams must be re-registered on the Australian Canine Computer (ANKC) system before the litter can be registered.
- Imported semen or semen from non-Australian resident sires must be re-registered on the Australian Canine Computer (ANKC) system before the litter can be registered.
- Any dogs not included in this application may cease to be eligible for registration.
- All live puppies in the litter must be registered.**
- A signed **Limited** Register Agreement **MUST** be attached to this application for every pup to be transferred that is on the Limited Register.
- A signed **Main** Register Agreement **MUST** be attached to this application for every pup to be transferred that is on the Limited Register.
- In the NT, the breeder is required to lodge the transfer of ownership for the puppy with the DogsNT office themselves.
- Under **NACA Rule 7.16** the breeder must **NOT** give a new owner the pup's signed registration paper.
- NEW OWNERS DETAILS (PAGE 4):** ONLY to be used if transferring to new owners at the time of Litter Registration. Transfer fees are applicable.
