Bayden was born to be amongst the dog trialling and showing community, starting out while he was still in his mum's belly when she competed in the Obedience Ring at the 2007 Darwin Royal. Bayden has grown up around dogs and was always present "trialling" the family Border Collie, Trey, in Obedience and Agility (with a bit of help from Mum). At the age of 11, and after watching how it all worked, it was his turn to get his own dog and the start of his dream team. He was lucky enough to get the pick of the litter from Jaylbros Border Collies and from the moment we brought him home, Thunda and Bayden became best of friends.

Their career started with multiple Dog of the Month graduations from the Darwin Obedience Dog Club and competed in their first shows in August 2019, taking out 4x Baby Puppy of Breed and topping it off with a Baby Puppy in Group.

Bayden and Thunda proved that the brains can come with the looks by gaining their Rally Novice title in 3x straight trials with scores of 84/100, 89/100 and 95/100.

Over the next couple of years Thunda took out multiple Best of Breed, Runner up In Group and an NT Bred in Show.

Move forward to the Darwin Royal 2022 and with only 4 points needed for their Champion Title, Bayden and Thunda were awarded Dog Challenge, Best of Breed, and NT Bred in Group. With a very nervous handler before heading out for the line-up. Bayden and Thunda take out NT Bred in Show for the 2022 Darwin Royal Show, what a way to end your title.

We look forward to what the future holds for these two.

A huge thank you goes to Cindy Bartlett, for bestowing Thunda to us and for all the guidance and help throughout the last 3 years.

## DOGSNT RULE CHANGES

### SECTION 3 – EXHIBITIONS

#### PREVIOUS RULE:

##### 3.4.4.- PERMISSION: PRIOR TO EVENT

**3.4.4 NOTE:** Due to the COVID-19 situation - the current DogsNT Rule 3.4.4 relating to the lodgement of pre-exhibition paperwork no less than four (4) months prior be lifted (no longer apply), from the 7th of May 2020 until the 31st of August 2022 (12/11/2021)

ALL official DogsNT pre-exhibition paperwork is now required no less than four (4) calendar weeks before the proposed event. (12/08/2021)

~~At least four (4) months before the proposed date of ANY Exhibition, the Affiliate shall submit (NOTE: Conformation Ring Steward Contracts exempt: see (e) below) (04/20):~~

- ~~Schedule in such a manner as may from time to time be prescribed by the Council.~~
- ~~Appropriate fees.~~
- ~~For Exhibitions (Conformation) a signed Judges contract for each Class/Breed of dog, for approval, or otherwise, by the NACA.~~
- ~~For Exhibitions (Trial) a signed Judges contract for each discipline that the judge is judging on the day.~~
- ~~A signed Conformation Ring Steward contract is to be submitted at least one (1) calendar month before the date of an Exhibition or in such a manner as may from time to time be prescribed by Council for each Exhibition. (04/20)~~

## Ehrlichiosis

### Protect your dog

Ehrlichiosis, a tick-borne dog disease, has been detected in the Northern Territory and is present in all areas, including Darwin, Palmerston, Katherine, Tennant Creek, Alice Springs and remote communities.

Ehrlichiosis is a bacterial disease spread by the brown dog tick. Once the disease is in the brown dog tick population it's very difficult to control.

Prevention is the best protection as vaccinations are not available.

#### Protect your dog from ehrlichiosis

- Have your dogs on a tick control program. Tick collars and spot-ons are the best primary protection used in combination with tablets and chews registered for tick control.
- Ensure any tick infestations in the house yard are managed by a pest controller.
- Avoid taking your dogs into tick-infested areas.

#### Inspect your dogs daily for ticks

- Run your fingers through your pet's coat, feeling for ticks that may be attached to the skin.
- Pay attention to the head, neck and ears, chest, between their toes and around their mouths and gums.
- Remove ticks carefully using a tick remover such as fine tipped forceps or your fingertips, grabbing it as close to the skin as possible, avoiding squeezing the body of the tick.
- Kill the tick by putting it in alcohol, into a sealed container and then into the rubbish.

### Prevent ticks from biting your dog

- Use a tick control product which repels ticks, such as a tick collar or spot-on. Products which rely on the tick biting the dog to work may not prevent ehrlichiosis. Ask your vet for advice about which product best suits your needs.
- Controlling ticks in your environment is critical. Ticks can live in cracks and crevices around your house and yard, around kennels, and inside skirting boards, window and door frames and can survive for many months without feeding. Speak with a professional pest controller about treating your home.

### Travelling or boarding your dog?

Before hitting the road:

- Check in with your vet to assess disease prevention requirements such as vaccination, worming, tick and flea control, heartworm preventive.
- When travelling avoid contact with other dogs when stopping, such as at fuel stations, truck stops or caravan parks, to avoid transfer of infected ticks between dogs.

### Ehrlichiosis

It is important to seek veterinary advice and treatment as ehrlichiosis can resemble other tick-borne dog diseases. Early treatment provides the best chance of recovery.

If you suspect your dog is showing signs of the disease, consult your local vet for further advice about diagnosis and treatment.

- When boarding your dog, make sure their tick, flea and worming prevention and vaccinations are up to date. Check with your local boarding kennel on mandatory disease prevention requirements.

### Look out for the signs

- fever
- lethargy
- loss of appetite
- weight loss
- swelling of the chest or front legs
- cloudy eyes or conjunctivitis
- pain and stiffness
- bleeding disorders such as nosebleeds or bruising on the gums or belly.

## ROTTWEILER SURVEY RESULTS

A Rottweiler Natural Bobtail survey was conducted by Dogs Australia last year to ascertain feedback from all owners of registered Rottweilers as Dogs Australia follows the Country of Origin breed standard and given that the gene involved is an incomplete dominant there is the possibility of bobtail parent/s producing long tail offspring. Only the long tail offspring are eligible to be placed on the Main Register.

The response received indicated support.

As this was an amendment to current regulations, the result of the survey was referred to the Dogs Australia Board of Directors for consideration at their June 2022 Special Board meeting where it was endorsed.

Consequently, the following new clause will be added to Regulations Part 6 – The Register & Registration which will be effective from 1 January 2023:

8.9.2 Effective 1 January 2023, any Rottweiler born a Natural Bobtail will be eligible to be registered on the Limited Register only and flagged **NOT TO BE UPGRADED**.

## MINIATURE AMERICAN SHEPHERD

This breed has now been added to the business system and we are currently arranging for our website to be updated with the relevant breed standard.

In addition, the Group listing will be updated with this breed being allocated to **Group 5 (Working Dog)** as confirmed by the National Breed Standards Coordination Group Chairperson, Mrs Marie Merchant.

## DOGS AUSTRALIA: JUNE 2022 SPECIAL BOARD MEETING SUMMARY

At the June 2022 ANKC Ltd Special Board meeting, Directors resolved/considered the following:

### 1. \* ANKC Ltd Regulations Part 5 – Conformation Show, Clause 3.2.8

It was RESOLVED that Regulations Part 5 – Conformation Show be amended with the removal of Clause 3.2.8 which currently reads:

**3.2.8** A judge cannot exhibit, and any dog owned by a judge cannot be exhibited at a conformation show where that judge has been on the panel at one of the conformation shows using the same panel of judges at a cluster of shows.

Note: This amendment to the regulations will be effective 1 July 2022.

### 2. \* ANKC Ltd Regulations Part 6 – The Register & Registration, Clause 8.16

It was RESOLVED that Regulations Part 6 – The Register & Registration Clause 8.16 be suspended until further notice.

#### 8.16 Afghan Hound (Added 02/22 – 6.1, Effective 1 July 2022)

The Minimum Breeding Age for Afghan bitches is 24 months at the time of mating (unless a veterinary certificate is produced stating that for health reasons the bitch should be mated before 24 months).

Breeders of litters whelped on or after 1 June 2022 will be required to comply with the requirements as a prerequisite to registration of any litter on the ANKC Ltd Main Register. Litters which do not meet the above requirements will only be able to be placed on the Limited Register and will be flagged not to be upgraded.

Note: This suspension to the regulations is effective immediately.

### 3. \* ANKC Ltd Regulations Part 6 – The Register & Registration, Clause 6.9

It was RESOLVED that Regulations Part 6 – The Register & Registration Clause 6.9 be amended to read as follows:

#### 6.9 Registration of Sporting Dogs – on Sporting Register (Added 10/10, 5.11)

**6.9.1** A dog that is registered with an ANKC Ltd recognised Working Dog Association or Kindred Body that caters for Working, Sporting or Performance Dogs may be registered on the National Database Sporting Register. (Amended 10/15, 7.5.18) (Amended 02/19, 4.10.2 – effective 01/07/19)

## DOGS AUSTRALIA: JUNE 2022 SPECIAL BOARD MEETING SUMMARY

**6.9.2** A Working, Sporting or Performance register dog registered with an ANKC Ltd overseas recognised Working Dog Association or Kindred Body to be re-registered with ANKC Ltd must provide, at the time of registering the dog, the following:

- a. Proof of identification, such as microchip
- b. Proof of Importation, such as a "health permit", "export permit" or "import permit"
- c. Proof of Shipment from the country of origin to Australia such as transportation documents "Airway Bill" OR
- d. Authorised Agency under the Bio Security Act 2016, Bio Security Release form (b and c above are not required if you have the DAWE release) (Added 02/19, 4.10.3 – effective 01/07/19)

**6.9.3** When a dog is to be transferred to the ANKC Ltd database Sporting Register a certified copy of the dog's registration or letter of authenticity, issued by the recognised body (either national or international), must be provided, which indicates the registered owners name and address.

**6.9.4** For the dog to be registered on the sporting register the Australian owner must be a financial member of an ANKC Ltd member body.

**6.9.5** The dog is to be permanently identified (such as microchip) and the permanent identified number is to be recorded on the National Database.

**6.9.6** The breed is to be recorded as 'Sporting' and only the following details, as assigned by the recognised Working Dog Association/Kindred Body, a list of which can be viewed via [http://ankc.org.au/media/9304/ankc-ltd-\\_wdakb-list\\_feb-19.pdf](http://ankc.org.au/media/9304/ankc-ltd-_wdakb-list_feb-19.pdf), are to be recorded on the National Database:

- a. prefix (if available) and name (in the one field);
- b. number as assigned by the kindred body;
- c. sex – M or F;
- d. microchip number;
- e. date of birth;
- f. colour (Amended 02/19, 4.10.1 – effective 01/07/19) 15; and
- g. Parentage if available.

**6.9.7** The ANKC Ltd Member Body will produce a Sporting Register Certificate for a Sporting dog, which indicates the above details.

**6.9.8** A litter born to both the Sire and Dam on the Sporting Register may be registered on the sporting register where the owner has a registered prefix with the ANKC Ltd and is a current financial member of an ANKC Member body.

**6.9.9** To be recognised as a Working Dog Association or Kindred Body the entity must make application to the ANKC for recognition. The application must stipulate the activities conducted by the entity, time in existence, number of members and dogs registered to them and why they are making application to be associated with the ANKC Ltd. The ANKC Ltd Board of Directors is to assess the application at the next available board meeting and notify the entity as soon as possible after the meeting.

Note: This amendment to the regulations will be effective 1 January 2023.

## DOGS AUSTRALIA: JUNE 2022 SPECIAL BOARD MEETING SUMMARY

### 4. \* ANKC Ltd Regulations Part 6 – The Register & Registration, Clause 8.2

It was RESOLVED that Regulations Part 6 – The Register & Registration Clause 8.2 be amended to read:

**8.2** The minimum breeding age for bitches across all breeds is 12 months at the time of mating unless there is a Litter Registration Limitation (LRL). This regulation is not intended to reduce minimum age requirement for breeding set out in the Code of Ethics of Member Bodies and the Rules of National Breed Councils and/or Breed Clubs. (Added 10/10, 6.7) (Amended EAP 07/11)

Note: This amendment to the regulations will be effective 1 January 2023.

The Board agreed a general statement is to appear at the beginning of the regulations which will read:

Any State, Federal or local legislation takes precedence over these regulations.

### 5. \* ANKC Ltd Regulations Part 6 – The Register & Registration, Clause 8.9.2

It was RESOLVED that Regulations Part 6 – The Register & Registration with the addition of Clause 8.9.2 to read as follows:

Effective 1 January 2023, any Rottweiler born a Natural Bobtail will be eligible to be registered on the Limited Register only and flagged NOT TO BE UPGRADED.

### 6. \* ANKC Ltd Regulations Part 6 – The Register & Registration, Clause 9.19.2

It was RESOLVED that Regulations Part 6 – The Register & Registration Clause 9.19.2 (German Shepherd Dog Stock Coat and Long Stock Coat inter-variety breeding) be amended to read as follows:

**9.19.2** Inter-variety breeding will be allowed for a period of seven years from 1 January 2023, and progeny from parents of either coat variety may be registered on Main and Limited Register under the appropriate coat variety until further notice. (06/22, 4.2)

### 7. \* ANKC Ltd Regulations Part 6 – The Register & Registration, Section 10

It was RESOLVED that Regulations Part 6 – The Register & Registration Section 10 Clause 10.1.1 be amended to read as follows:

### SECTION 10: Recognition of New Breeds – (Added 10/21, 5.20)

**10.1** Requirements for the Recognition of any breed, which is recognised by a recognised Overseas Controlling Body.

**10.1.1** ANKC Ltd. recognises all breeds recognised by the FCI whether on the definitive or provisional register. The breed standard will be adopted and published when a specimen of the breed is imported into Australia. Breeds on the FCI Provisional Register may be awarded challenge certificates but are not eligible to be awarded a CACIB

Note: This amendment to the regulations will be effective 1 January 2023.

### 8. \* ANKC Ltd Code of Practice of Responsible Dog Ownership

It was RESOLVED that the Code of Practice of Responsible Dog Ownership Clauses 13, 14, and 15 be amended as follows:

**13.** A member shall not breed a bitch causing it to whelp more than twice in eighteen months. (Amended 06/22, 4.2)

**14.** A member shall not breed a bitch causing it to whelp more than six times. (Amended 06/22, 4.2)

**15.** A member shall not breed a bitch which is eight years of age and over unless it complies with ANKC Regulations Part 6 Clause 8.3. (8.3 All bitches eight years of age and over at the time of a mating must have a current veterinary certificate stating that the bitch is in good health at the time of breeding. This certificate must be presented at the time of registration of the litter resulting from this mating. A current veterinarian certificate is defined as being within three months prior to the mating. (Added BOD 10/11)) (Amended 06/22, 4.2)

Note: This amendment to the Code of Practice will be effective 1 January 2023.
