After downsizing from Whippets, 'Gorgeous Gus' was the first Italian Greyhound (IG) to join the Kosmos sighthound pack. Originally bought as a 'pet', Gus hit the show ring later than most destined to strut the 'dog walk', and debuted at five years old when the Neuter Champion title was introduced.

As it happened, the Alice Springs Kennel and Dog Sports Club Inc held the championship shows where the first Neuter Champion points were to be awarded. Well, Gus wasn't going to miss an opportunity like that! So, on that bitterly cold and wet July morning, with all eyes upon him, Gus (who seemed to know that this was his big moment), bravely faced the Antarctic conditions, and avoiding the frosty bits with his hallmark 'high stepping free action', was historically awarded the world's very first Neuter Challenge points! The crowd went wild and, in that small Northern Territory outback town, the icy bone chilling wind suddenly didn't seem to matter anymore as this proud little gaze hound had just made both breed AND world history!

To prove he wasn't just a 'First in the world Gussy', this much-loved little dog then went on to prove how 'fit for purpose' he was by gaining his Endurance Trial title with ease – making him the first dual-titled IG for Kosmos Kennels. Rest in peace darling Gus – you truly were one of the special ones.

**DID YOU KNOW?** It is thought the Italian Greyhound originated over 4,000 years ago in the Mediterranean Rim. In Greece and Turkey, small skeletons and decorative art depicting the small hound have been found. Small skeletons, still wearing their bejewelled collars, have also been found in the tombs of ancient Pharaohs, and can be seen in the Cairo Museum and, it is rumoured that Cleopatra owned one – gifted to her by the Roman General, Marc Antony.

In the ruins of Pompeii these small hounds have been found in lava flows and the Latin inscription "Cave Canem" ('Beware of the Dog'), found in floor mosaics of houses of that period, was not a warning, but a reminder not to step on the precious miniature hounds!

Catherine the Great of Russia had a favourite IG named *Zemira*. Now buried in Peterhof Park, St Petersburg a life-size porcelain figurine of *Zemira* was commissioned. An annual holiday on 27<sup>th</sup> July in St Petersburg still celebrates "The Wind Plaything" Italian Greyhound festivities dedicated to Catherine's beloved *Zemira*.






