Tulip created history at the Royal Darwin Show in July 2023 when she achieved a last qualifying pass in Masters Jumping to obtain her final points for her Agility Champion 400 title. She has become both the first dog in the Northern Territory and the first purebred Australian Cattle Dog to achieve this title. Tulip currently has 36 titles, currently making her the highest-titled Australian Cattle Dog nationally.

Tulip came into my life in early 2013 with high ambitions to follow in the pawprints of her counterpart Cooroorah Catchmeifyoucan ('Schooner'). Kerrie Carlson entrusted Tulip to me and being a soft girl, I allowed her time, and she has become very consistent in the agility and show ring. Although she has achieved titles in Obedience and Rally (although not our favourite thing), it shows how versatile she is. Now at ten and a half years old, and with retirement looming, every time we enter the ring it's precious time together and a memory in the making.

Tulip was part of the NT team at the Agility Nationals in Adelaide in 2016 and the only dog in the NT team to achieve a clear round in the jumping round, although 'over time' in very trying conditions. She has won the 'Echo and Midi Trophy' at the Royal Darwin Show four times, in 2016, 2018, 2022 and 2023 and has also won 'Top Trialling Dog' at Fred's Pass Positive Dog Training Club in 2018 and 2022.

Tulip became a mum in February 2016 giving Echomidi Kennels their first litter of three puppies. Her son, Echomidi Stuttin His Stuff ('Yardie'), became part of Team Echomidi until he lost his battle to stay with us on 6 January 2023. She was desexed in early 2017, so I decided to show her in Neuter classes in 2020 - and she gained that title very quickly, including winning several Neuter in Show awards! She is still out there competing in the Neuter classes at conformation shows and doing well.

DID YOU KNOW? The Australian Cattle Dog was developed in Australia during the 19th century as a working or drover's dog. Breed traits were selected to produce a dog with immense stamina, resilience, and tenacity, able to deal with untamed cattle, rugged terrain, and vast distances. These dogs had to be biddable and make quick decisions on their own, with large and dangerous mobs of wild cattle. Their job included protecting the drover, his horse, and belongings, if necessary. Years of breeding to suit droving needs have produced a dog with superb ability as well as a general-purpose dog of excellence.

Their valuable assistance has enabled Dogs NT to replace the old halogen globes with new LED ones, which will provide brighter and a more cost-effective lighting for our grounds.

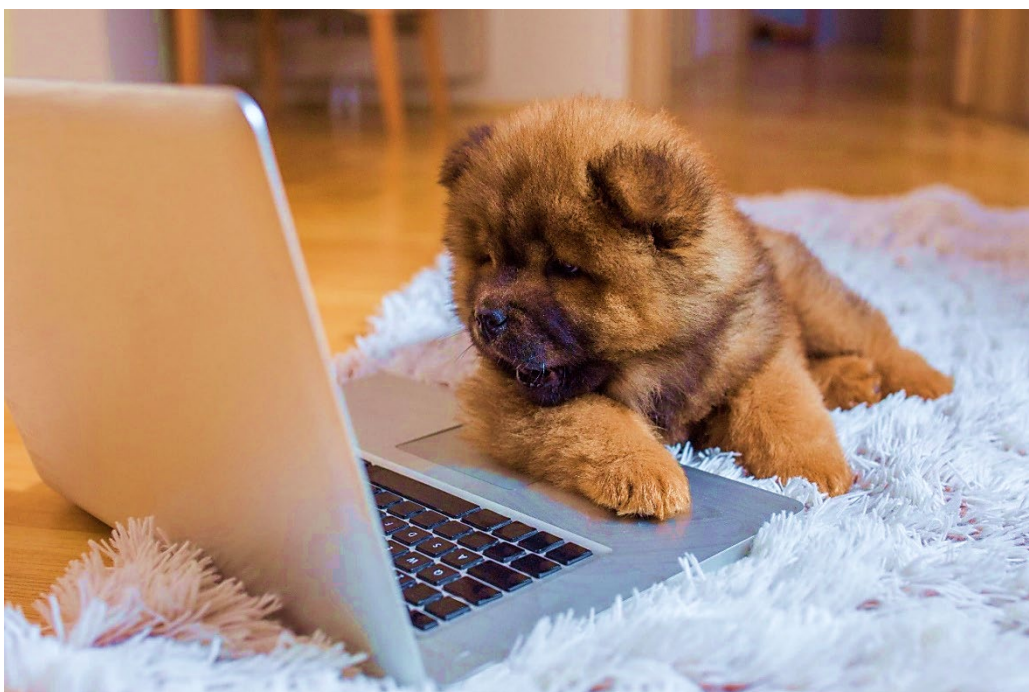
This much-needed upgrade was long overdue, and it would not have been possible without the support of the CBF grant offered by the NT Government.

New Regulation Part 5 - Conformation Show, Clause 2.7 - effective 01 January 2024:



Please note **Regulations Part 5 – Conformation Show** has been updated with new **Clause 2.7** relating to the use of Ramps/Tables in accordance with **Item 4.3** of the June 2023 Special Board meeting minutes.

DOGS AUSTRALIA RULES AND REGULATIONS

**DOGS AUSTRALIA: REGULATION CLARIFICATION - SEC 5: CONFORMATION SHOWS.**

Dogs Australia wishes to clarify **Regulations Part 5 – Conformation Shows Clause 1.2.1 – Bred by Exhibitor – Class 14** which currently reads:

Bred by Exhibitor: Class 14: For dogs aged six months and over. The exhibit must be owned and handled by the breeder of record. The exhibit must be handled throughout the breed classes, all group and general specials classes by the owner or part owner of the prefix under which the exhibit was originally registered.

CLARIFICATION:

If an exhibit is entered in class 14, it must be handled by the owner/breeder at all times right through to Best in Show. No one other than the breeder/owner may handle the exhibit at any stage of the show.

If 2 exhibits are owned/bred by a single person and the two exhibits are entered by the same person in **Class 14**, the owner/breeder may determine which exhibit he/she will handle and the other exhibit would have to be withdrawn. If an exhibit is owned/bred by a partnership, then any member of the partnership may handle the exhibit through to Best in Show.

To give an extreme example, if three exhibits of three different breeds are entered in class 14 and are owned/bred by the same couple and they all win Best in Group. Then, for Best in Show, the couple could handle two of the exhibits and the third would have to be withdrawn.

Dogs Australia are arranging for this clarification to be published on their social media page.

DOGS AUSTRALIA: RULES FOR THE CONDUCT OF AGILITY TRIALS AND AGILITY GAMES – ORIGINAL RULE 7.2 REINSTATED

In 2020 **Rule 7.2** in the Rules for the Conduct of Agility Trials and Agility Games was temporarily modified to safeguard Trial officials against the transmission of COVID. The States and Territory governments are now free from any COVID restrictions which makes this rule modification redundant.

The National Agility Committee members has agreed the temporary rule is no longer required and the original **Rule 7.2** should be reinstated **effective immediately**.

Please be advised that the temporary rule that was mandated in 2020 is now unnecessary and we ask that you revert to the **original Rule 7.2** in the Rule Book as noted below. Should a future restriction be put in force in any State or Territory, that Member Body may reinstate the COVID modification until such time as the restriction is lifted without referring to Dogs Australia for approval.

7.2. ENTERING AND EXITING THE RING

On the Steward's call of the dog's catalogue number, the Handler will enter the ring via the entry point, with the dog on lead either carried or walked and follow the Steward's and/or Judge's instructions. The lead and harness or head collar must be removed, the collar may be removed and all items handed to a Steward or may be placed on the ground behind or in a provided nearby receptacle. The steward will remove items after the dog/handler team commences their run.

DOGS AUSTRALIA: SUMMARY OF THE DOGS AUSTRALIA SPECIAL BOARD MEETING - HELD VIA ZOOM VIDEO CONFERENCING ON 17 JUNE 2023



At the June 2023 ANKC Ltd Special Board meeting, Directors resolved/considered the following:

1. * ANKC Ltd Regulations Part 5 – Conformation Show, New Clause 2.7

It was RESOLVED that **Regulations Part 5 – Conformation Show** be amended with the addition of **Clause 2.7** to read as follows:

2.7 Use of Ramps/Tables

2.7.1 A current list of table, ramp and ground judged breeds may be found on the Dogs Australia website.

2.7.2 Table Breeds - Designated table breeds must be examined on an examination table. When re-examining them, they must be placed back on the table. Only breeds designated as table breeds may be examined on the table.

2.7.3 Ramp Breeds - A judge requesting the use of a ramp must give notice to the show representative/show manager prior to judging. Dogs Australia/ member body approval is not required. Designated ramp breeds may be examined on the ground (table if applicable) or on a ramp during breed judging at the sole discretion of the judge and not the exhibitor.

The entire entry in that breed is to be examined on the ground (table if applicable) or on a ramp. The ramp will be Available at the discretion of the judge for all ramp optional breeds through all levels of competition including group and Best in Show judging.

2.7.4 Breeds designated as Table/Ramp optional breeds may be judged on either at the sole discretion of the judge and not the exhibitor. The entire entry in a breed is to be examined in the same manner.

2.7.5 All Other Breeds Breeds not designated as either table or ramp breeds may only be examined on the ground.

2.7.6 Baby Puppies of any breed - Baby puppies may be examined on the ground, table or ramp at the discretion of the Exhibitor and Judge.

DOGS AUSTRALIA: SUMMARY OF THE DOGS AUSTRALIA SPECIAL BOARD MEETING - HELD VIA ZOOM VIDEO CONFERENCING ON 17 JUNE 2023 (CONTINUED):

2.7.7 Guidelines for Construction of a Judging Ramp

Ramps acquired from date of implementation should conform to the following specifications:

→ **Construction:** Any stable material, including the use of folding legs if required.

→ **Surface:** non-slip such as; rubber-mat, artificial turf, outdoor carpet.

→ **Weight:** the weight any ramp shall not exceed 16kg (in accordance with WHS guidelines) except in the case where the ramp is mobile by form of attached wheels (can be pushed rather than carried or lifted).

Dimensions:

→ Length: 120 cm

→ Width: 60 cm

→ Height: 40 – 60 cm

→ Slope: no greater than 30°

NOTE: Please refer to **Regulations Part 2 – Judges, Clause 1.4** in relation to the declaration contained on all judges Application Forms, both new and renewal regarding fitness to judge.

NOTE: This amendment to the regulations will be effective **1 January 2024**.



DOGS AUSTRALIA: SUMMARY OF THE DOGS AUSTRALIA SPECIAL BOARD MEETING - HELD VIA ZOOM VIDEO CONFERENCING ON 17 JUNE 2023 (CONTINUED):

2. * ANKC Ltd Regulations Part 6 – The Register & Registration, Clause 1.7

It was RESOLVED that **Regulations Part 6 – The Register & Registration Clause 1.7** be amended to read as follows:

1.7 Greyhounds

All Member Bodies shall recognise registrations issued by the relevant Authority within that State/Territory. Owners must complete a re-registration application signed by the relevant Authority and accompanied by a copy of the Greyhound Identification Card or Pedigree. (04/84) (Amended 5/00) (Amended 10/16, 6.1) (Amended 06/23, 5.2 – effective 01/08/23)

NOTE: This amendment to the regulations will be effective 1 August 2023.

3. * ANKC Ltd Regulations Part 6 – The Register & Registration, Clause 3.2 (c)

It was RESOLVED that **Regulations Part 6 – The Register & Registration Clause 3.2 (c)** be amended to read:

3.2 All pedigree dogs that are imported into Australia except those imported from New Zealand (including dogs whelped in Australia and previously exported from Australia) to be re-registered with Dogs Australia must provide, at the time of registering the dog the following:

c. An original Export Pedigree and Ownership Certificate (if two separate documents) or a digital Export pedigree/ Ownership Certificate sent directly to the State Member Body Office from the Overseas Controlling Body, indicating the Australian member's name and current residential address showing all registration numbers, titles granted and colours by the overseas body. The Export pedigree must be at least first and second generations complete and the 3rd generation a maximum of 4 names missing.

NOTE: This amendment to the regulations will be effective 1 August 2023.

4. * ANKC Ltd Regulations Part 6 – The Register & Registration, Clause 6.3.4.12.1

It was RESOLVED that **Regulations Part 6 – The Register & Registration Clause 6.3.4.12.1** be amended to read as follows:

6.3.4.12.1 The State Member Body that initially first registers any dog with a shortened tail shall determine whether such shortening is legal. Any change to this status shall be the responsibility of the State Member Body that first made the notation on the registration.

All State Member Bodies shall recognise any determination by another State Member Body in relation to this matter.

NOTE: This amendment to the regulations will be effective 1 August 2023.



DOGS AUSTRALIA: SUMMARY OF THE DOGS AUSTRALIA SPECIAL BOARD MEETING - HELD VIA ZOOM VIDEO CONFERENCING ON 17 JUNE 2023 (CONTINUED):

5. * ANKC Ltd Regulations Part 6 – The Register & Registration, New Clause 8.16A

It was RESOLVED that **Regulations Part 6 – The Register & Registration** be amended with new **Clause 8.16A** to read as follows:

8.16A Dobermann

8.16A. Effective **1st January 2024**, any Dobermann born a Natural Bobtail will be eligible to be registered on the Limited Register only and flagged NOT TO BE UPGRADED as they do not conform with the breed standard.

NOTE: This amendment to the regulations will be effective **1 January 2024**.

6. * ANKC Ltd Regulations Part 6 – The Register & Registration, Clause 6.11.4

It was RESOLVED that **Regulations Part 6 – The Register & Registration, Clause 6.11.4** which currently reads as follows to be removed in its entirety effective **1 January 2024**:

6.11.4 In addition to compliance with **6.11.1** any Dobermann applying to be registered as a Natural Bobtail (NBT) must also show DNA proof of purity of breed. Where the certification of the dog being a NBT is by DNA testing, the DNA testing for proof of purity of breed must be conducted by an independent testing laboratory to that of the NBT testing. Effective for matings after the **1 June 2022**. (Added 10/21, 9.4) (Amended 05/22, EM#199)

7. * ANKC Ltd Regulations Part 6 – The Register & Registration, New Section 13

It was RESOLVED that **Regulations Part 6 – The Register & Registration Clause 8.16** be amended with new **Section 13** pertaining to the Conduct of Surveys to read as follows:

13.1 The Board of Directors may at their sole discretion, resolve to conduct a survey of members to gauge their opinion on any matter not covered by **Regulations Part 6 Clause 8.18** to assist it in making a decision.

13.2 If the survey is breed related, it will be limited to:

- a) voting current members of a Dogs Australia Member Body;
- b) who have held full continuous membership for the previous two years prior to the release of the survey; and
- c) currently own or have owned a Main Registered dog in the specific breed.

13.3 Surveys will be electronic, conducted by the Dogs Australia Administration.

NOTE: This amendment to the regulations will be effective **1 August 2023**.

8. * Dogs Australia Listing of Recognised Working Dog Associations or Kindred Bodies

It was RESOLVED that the Australian Sled Dog Sports Association be added to the Dogs Australia Listing of Recognised Working Dog Associations or Kindred Bodies.

- **Ms Roberta Strmecki – 3100032157:** The member appealed against the findings penalty. On 16 August 2023, the appeal was dismissed, and the penalty upheld: suspension for the duration of six (6) months effective from 25 July 2023
- **Mrs Paula Semmel – 3100001244:** Suspension of 12 months commencing 18/08/2023.
- **Mr Ron & Mrs Elizabeth Chapman – 3008728250:** The member appealed. On 31 August 2023, the appeal was dismissed, and the penalty was upheld: Suspension for the duration of Twelve (12) months effective from 3 August 2023.

Ehrlichiosis: Protect your dogs

THE
TERRITORY

Ehrlichiosis, a tick-borne dog disease, has been detected in the Northern Territory.

It is present in all areas, including Darwin, Palmerston, Katherine, Tennant Creek, Alice Springs and remote communities.

- Have your dogs on a tick control program. Tick collars and spot-ons are the best primary protection used in combination with tick control tablets and chews.
- Ensure tick infestations in the house yard are managed by a pest controller.
- Avoid taking your dogs into tick-infested areas.
- Inspect your dogs daily for ticks.
- Check when travelling or boarding your dog with your vet or local boarding kennel.
