Meet 'Nikki' – who, like so many of our past and present Northern Territory canines, was also a 'first' time achiever! This lovely, elegant, and muscular bitch was the first in the Territory to whelp a frozen semen litter, and what a historic moment that was. So many of her progeny followed in her cat-like paw prints and went onto be champions, which, given their impeccable breeding, was surely their destiny.

A very patient, typically intelligent girl, and with her breed ancestry flowing through her veins, she was happiest working alongside her humans. Consequently, she became in great demand as a Junior Handler dog, and quickly became a firm favourite amongst the younger exhibitors.

A multi–Best Exhibit in Show, Best Exhibit in Group and Best of Breed winner, it was a privilege indeed to watch this beautiful dog strut her stuff in the competition ring. With her typical proud carriage, correct energetic movement and unflappable attitude it was nothing short of pure canine poetry, and indeed, this was acknowledged repeatedly as the judges 'gave her the nod.' Of course, 'Nikki' expected nothing else, she was a star, and being a pure Dobermann through and through - she knew it!

A much-loved family protecter, companion and friend - she remains dreadfully missed, and in the Irlam family's hearts forever.

DID YOU KNOW? The Dobermann is a comparatively modern breed, and unusual in that one man is credited with its origin in the 1880s - Herr Louis Dobermann. A nightwatchman and tax collector, he bred for a large terrier-type dog which would be utterly fearless, highly intelligent and a first-class personal guard dog.

By the end of the 19th century, Otto Goeller took the rough breed and improved it enormously, retaining its alertness and exceptional qualities as a guard dog, whilst at the same time softening the breed so that it also became a good house dog.

Although physically strong, this breed is not a bully and can live in harmony with other dogs, and other pets. There is nothing mean about its character and his devotion and natural protective instinct make him an ideal companion and trustworthy canine member of the family. Intelligent and a quick learner, Dobermanns come in four colours and excel at a variety of activities, including Obedience, Tracking, Agility, Rescue, and police work, as well as showing capabilities as guide or therapy dogs.



Hi members,



A big thank you to Steve Russell, who has volunteered his own time to regularly mow our association grounds. Without volunteers like Steve, Dogs NT would cease to function, so I thank everyone who gives their time in support of our hobby. Thank you also to all who attended our recent grounds working bees.

Speaking of the grounds, we have secured a grant to replace doors and conduct maintenance work on the toilet block. These renovations are approved and will commence within the next few weeks. We are also in the process of treating the termite mounts in the training areas. This might cause some minor inconvenience to user groups but as you would understand, is necessary. We are also applying for a further grant to maintain and remove troublesome and dead trees by an arborist. All of which should be happening in the near future. A big thank you to Sarah Gordon for preparing the applications for these important minor works grants.

We have stream-lined paperwork through the 'Show Manager' site allowing, for example, title applications to no-longer require certificates to be lodged with the application. Council has also approved 'live results' on the day and breed numbers to be released prior to the show which weren't accessible before. All of which demonstrates how council is listening to the needs of members. I would also like to thank Rebecca Williams for running a workshop to help new club officials understand how to use the 'Show Manager' app.



DOGS AUSTRALIA SPECIAL BOARD MEETING

DOGS AUSTRALIA: SUMMARY OF SPECIAL BOARD MEETING – HELD VIA ZOOM VIDEO CONFERENCING 10 FEBRUARY 2024



At the February 2024 Dogs Australia Special Board meeting, Directors resolved/considered the following:

1. * Dogs Australia Rules for the Conduct of SprintDog™

It was RESOLVED that Dogs Australia approve the Rules for the Conduct of SprintDog™ Trials and the Dogs Australia SprintDog Qualifying Certificate to be effective from 1 July 2024.

2. * Dogs Australia Rules for the Conduct of Obedience Trials

It was RESOLVED to rescind the October 2023 Board meeting decision to amend the Glossary in the Rules for the Conduct of Obedience Trials as follows:

Page 3 Fouling Present Rule:

A dog which fouls at any time while it is under the control of the Judge must be disqualified.

Change to:

A dog which fouls at any time while it is under the control of the Judge must be disqualified and removed from the ring immediately.

Page 4 Disqualification Present rule:

No points awarded. The dog is disqualified from all Trial Competition on the day and the Judge must provide a written report to the Member Body within 14 days – the only exception being in the instances where the disqualification was incurred for continual barking, a correction penalty, fouling the ring or for handlers bringing training aids into the ring.

Change to:

No points awarded. The dog is disqualified from all Trial Competition on the day and the Judge must provide a written report to the Member Body within 14 days. The only exception being In instances where the disqualification was incurred for continual barking, a correction penalty, fouling the ring or for handlers bringing training aids into the ring, handlers will only be disqualified from that class and no report is required.

Note: This rescission motion will be effective 1 July 2024.

It was RESOLVED for these amendments to be referred to the National Obedience & Tracking Committee for recommendation.

4. * Dogs Australia Regulations Part 5 – Conformation Shows Section 7 – Amendment

It was RESOLVED that **Regulations Part 5 – Conformation Shows Section 7** Order of Judging be amended as follows:

Insert 7.1.5

(h) Where an All Breeds Championship Show is not concluding at General Specials as defined in **7.1.7** all in Group awards are to be signified as Best in Group, Runner-up in Group and Classes in Group as offered.

7.1.6

(h) Where an All Breeds Championship Show is not concluding at General Specials as defined in **7.1.8** all in Group awards are to be signified as Best Neuter in Group, Runner-up Neuter in Group and Neuter Classes in Group as offered;

and **Section 8** Alternative in-Group and in-Show Placing System be amended as follows: **8.3.7** General Specials is to be offered at all Alternative in-Group and in-Show Placing System Championship Shows

The following procedure is to be adhered to:

Where an affiliate is conducting more than one show on the same day and General Specials are not to be offered, it may only be at on the last show on that day.

Note: These amendments will be effective 1 April 2024.

5. * Dogs Australia Regulations Part 5 – Conformation Shows Clause 9.7.1 – Amendment

It was RESOLVED that **Regulations Part 5, Conformation Show Clause 9.7.1** be amended to read: Existing

- a. Classes ineligible for the CACIB to be awarded: (Amended 02/23, 5.11 Effective 01/07/23) Class 1 Baby Puppy For dogs aged three and under six months.
 - Class 2 Minor Puppy For dogs aged six and under nine months.
 - Class 3 Puppy For dogs aged six and under twelve months.
 - Class 12 Veteran For dogs aged eight years and over. (Added 02/23, 5.11 Effective 01/07/23)
- b. Classes eligible for the CACIB: (Amended 02/23, 5.11 Effective 01/07/23)
 Class 4 Junior For dogs aged nine and under eighteen months. (providing the winner is over 15months of age)
 - Class 5 Intermediate For dogs aged eighteen and under thirty-six months.
 - Class 11 Open For dogs 15 months and over that are not Champions
 - **Class 21** Champion To enter a dog in Champion Class, the title must have been confirmed by the issue of a Registered Pedigree Certificate with the title added by the day of the official closing date of entries.

Amended (WEF) 01 Apr 2024

- a. Classes ineligible for the CACIB to be awarded: (Amended 02/23, 5.11 Effective 01/07/23)
 - Class 1 Baby Puppy For dogs aged three and under six months. (Optional)
 - Class 2 Minor Puppy For dogs aged six and under nine months. (Optional)
 - Class 3 Puppy For dogs aged six and under twelve months. (Optional)
 - Class 4 Junior For dogs aged nine and under eighteen months. (Compulsory)
 - **Class 12 Veteran** For dogs aged eight years and over. (Compulsory) (Added 02/23, 5.11 Effective 01/07/23)

On 1 January 2024, the fees for reading hip and/or elbows xrays under the Dogs Australia CHEDS will increase. This is the first rise in fees since the implementation of the scheme in 2016. There will also be a levy introduced on all scheme readings in order to support the operation of the Dogs Australia Officially Registered Canine Health Information Database (ORCHID).

To participate in FCI Competitions a canine groomer must be member of a Dogs Australia Member Body, the introduction of Canine Grooming will see an increase in our membership. and bring the list of Competitive Sports that we offer to our members to fifteen.
