**ELIGIBILITY:** The Applicant must:

- i. Be a member of an ANKC Ltd Member Body for at least 3 years prior to the years application and be a current financial member of an ANKC Ltd Member Body.
- ii. I am over Eighteen (18) years of age.

- iv. Aspirants are expected to attend all lectures and practical training sessions unless otherwise approved by the relevant ANKC Ltd Member Body.
- v. Aspirants will also be required to educate themselves by studying the Rules for the Conduct of Rally Obedience Trials.
- vi. To be eligible to apply for a Rally Obedience Judges licence, the applicant will;
- vii. Have personally trained and trialed a dog to the minimum of 'Rally Novice' Title or 'Companion Dog' Obedience Title.
- viii. "I declare that I am physically fit and capable of judging in accordance with the Rules and if required I am prepared to undergo a medical fitness test and/or vision test at the discretion of the Member Body of ANKC Ltd. I further accept that my Member Body may at its absolute discretion refuse to grant any renewal of licence and may cancel or suspend for any period or vary in any way any licence already granted or to be granted." **ANKC Ltd Regs Part 2, Point 1.4**
